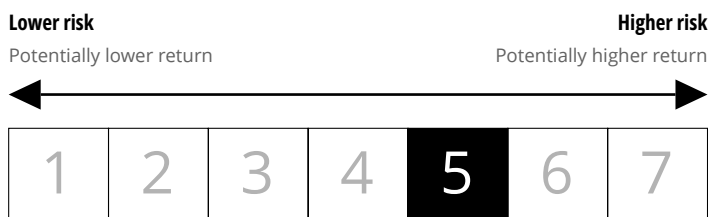
## Objectives and investment policy

The key features of the sub-fund are as follows:

- The Sub-Fund's investment objectives are to deliver sustainable positive returns with attractive Sharpe ratio over a recommended minimum investment period of three years while outperforming its reference indicator, calculated with coupons reinvested, and making a positive contribution to society and the environment.
- This Sub-Fund is an actively managed UCITS. The investment manager has discretion over the composition of its portfolio, subject to the stated investment objectives and policy. The Sub-Fund's investment universe is mostly independent from the indicator. The Sub-Fund's investment strategy is not dependent on the indicator; therefore, the Sub-Fund's holdings and the weightings may substantially deviate from the composition of the indicator. There is no limit set on the level of such deviation. The reference indicator is the JP Morgan GBI – Emerging Markets Global Diversified Composite Unhedged EUR Index.
- In a bid to outperform the reference indicator, the sub-fund is invested mainly in emerging markets debt instruments, without restriction in terms of rating or currency denomination. The sub-fund may also hold ancillary positions in bonds issued by sovereign issuers of developed market countries. The overall modified duration of the portfolio, defined as the change in portfolio capital (as %) for a change in interest rates of 100 basis points, may fluctuate between -4 and +10.
- The manager may use Relative Value strategies as performance drivers, looking to take advantage of the relative value between different instruments. Short positions may also be taken through derivatives.
- This Sub-Fund has a sustainable objective to invest in sovereign debt investments whose ESG criteria are dynamically improving in accordance with article 9 of the Sustainable Finance Disclosure Regulation ("SFDR"). The ESG indicators are composed of publicly available data and calculated on a monthly basis. Negative Screening is used to actively reduce the Sub-Fund's corporate bond investment universe by at least 20%. Examples of ESG criteria include for Sovereign issuers (E) share of renewable energy, (S) education and (G) ease of doing business, and for Corporate issuers (E) carbon emissions data, (S) human capital policies, (G) minority shareholder treatment. With respect to sovereign issuers, the Sub-Fund may not have perfect coverage of all the relevant ESG indicators at all times.
- The geographical investment universe of the sub-fund is global, including emerging countries.
- The sub-fund uses derivatives for hedging or arbitrage purposes, or to expose the portfolio to the following risks (directly or via indices): currencies, interest rates, credit (up to 50% of the net assets), volatility and variance (together not exceeding 10% of the net assets). The derivatives available are options (vanilla, barrier, binary), futures and forwards, swaps (including performance swaps, as well as credit default swaps) on one or more underlyings.
- Up to 10 % of the net assets may be invested in contingent convertible bonds ("CoCos"). CoCos are regulated subordinated debt instruments that are complex, but consistent in nature. Please refer to the prospectus for more information.
- The sub-fund may invest up to 10% of its net assets in units or shares of investment funds.
- This sub-fund may not be suitable for investors planning to withdraw their investment within three years.
- Investments may be redeemed each business day on request. Subscription and redemption requests are centralised on each NAV calculation and publication day before 18:00 CET/CEST and are executed on the next business day using the previous day's NAV.
- This is an accumulation share.

## Risk and reward profile



This indicator represents the annual historical volatility of the sub-fund over a 5-year period. Its aim is to help investors understand the uncertainty attached to gains and losses that may have an impact on their investment.

Risks to which the sub-fund may be exposed and which could lead to a fall in the net asset value to which the indicator gives too little consideration:

- Credit risk: the sub-fund is invested in securities whose credit rating may decline, meaning there is a risk that the issuer may not be able to meet its commitments. Should an issuer's creditworthiness decline, the value of the bonds or derivatives linked to this issuer may fall.
- Counterparty risk: the sub-fund may suffer losses if a counterparty defaults and is unable to meet its contractual obligations, especially in the case of derivatives traded OTC.
- Risks associated with China: investing in this sub-fund entails risks associated with China, especially risks associated with the use of Stock Connect (a system facilitating equity investment in the A shares market via a Hong Kong-based entity acting as the sub-fund's nominee). Investors are advised to familiarise themselves with the specific risks of this system, as well as with other risks linked to investments in China (CIBM, RQFII status...) as outlined in the prospectus.

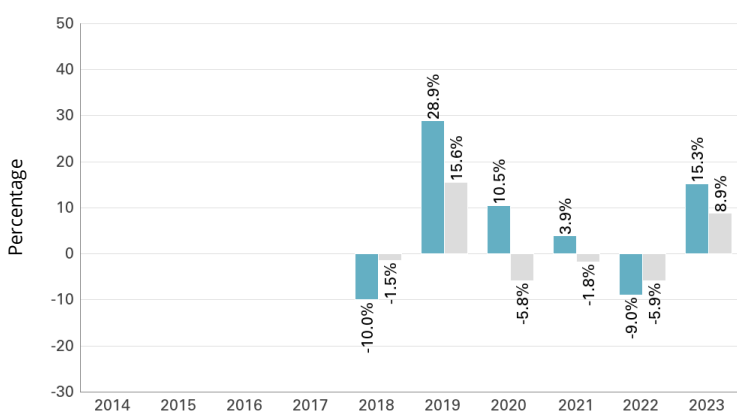
